Information clause on the protection of personal data

Pursuant to Art. 13 of the General Data Protection Regulation of 27.04.2016. (DZ. UE L. 119 of 04.05.2016) we would like to inform you that:

1. The administrator of your personal data is the Foundation for Freedom, ul. Ordynacka 9, 00-364 Warsaw. Contact with the Foundation's personal data administrator is via the e-mail address info@fundacjadlawolnosci.org
2. Your personal data will be processed for the purposes necessary to carry out recruitment and classes as part of projects implemented by the administrator, within which sports activities are conducted, in particular preparing reports on the activities carried out, which will be transferred to entities financing the classes and which may be made public, as well as confirmation of the eligibility of expenses, providing support, evaluation, control, audit and reporting.
3. The recipients of your personal data will be:
 - only entities authorized to obtain personal data under the law,
 - persons authorized by the administrator to process data as part of the performance of their official duties,
 - entities to which the administrator commissions or authorizes to perform activities related to his business, which involves the need to process data, in particular IT, law and accounting companies (processing entities).
4. Your personal data will be stored for the period until the completion of the project(s), in which you will participate, and then for archival purposes and reporting for a period of 5 years from the beginning of the year following the year, in which the project was completed or within the period required by law, depending on which of these periods is longer or until you withdraw your consent.
5. You have the right to access your data and rectify, delete or limit processing at any time, as well as the right to object, submitting a complaint to the supervisory authority, requesting cessation of data processing and transfer, as well as the right to withdraw consent at any time. Withdrawal of consent during classes will be treated as resignation from participation in classes.
6. The personal data provided by you will not be processed in an automated manner and will not be subject to profiling.
7. The personal data provided by you will not be processed in an automated manner and will not be subject to profiling.
8. Providing personal data is voluntary, but necessary to implement the project in which sports activities are conducted and to participate in them.
